Know all by these presents, that the undersigned hereby makes, constitutes and appoints Jessica Tracy and Bianca Lazar, each acting singly, and with full power of substitution and re-substitution, as the undersigned's true and lawful attorney-in-fact (such person and her substitutes being referred to herein as the "Attorney-in-Fact"), with full power to act for the undersigned and in the undersigned's name, place and stead, in any and all capacities, to:
